#### March 13, 2003 / U.S. CENSUS BUREAU RELEASES FIRST REPORT ON SAME-SEX PARTNERS AND THEIR FAMILIES

Landmark Report Sheds New Light on Number of Same-Sex Partner Households Raising Children, Average Age and Race of Same-Sex Couples

WASHINGTON — The Human Rights Campaign applauded the U.S. Census Bureau today for a report it released that, for the first time, gives data on the nation's families headed by same-sex partners. The report gives information on the number of same-sex partner households in the nation that are raising children, the average age of same-sex couples, and the racial makeup of same-sex couples.

"This is a landmark as it is the first time any government institution has worked to gather and publish information on this country's gay families," said HRC Communications Director and Senior Strategist David M. Smith. "These numbers are compelling evidence that more needs to be done legislatively to provide the same protections to same-sex couples and their families that are already available for nongay families."

The report was compiled on data taken during the 2000 U.S. Census. Previously released census data revealed that there are 594,391 reported same-sex households in the country – of those, 301,026 are male partners, and 293,365 are female partners. Those same numbers also showed that gay and lesbian families live in 99.3 percent of all counties in the United States.

"We firmly believe that those numbers are artificially low, as many gay people in this country are still afraid to step forward and identify themselves because of the threat of discrimination," said Smith.

The new report showed that one third of female partner households (34.3 percent), and one fifth of male partner households (22.3 percent) are raising children. Currently, eight states and the District of Columbia, along with scattered counties across the country, guarantee same-sex couples access to second-parent adoption, which permits both parents to establish a legal relationship to any child they might raise together, according to HRC Foundation's FamilyNet project (www.hrc.org/familynet), the most comprehensive resource on gay, lesbian, bisexual and transgender families.

"Children in all families deserve the security of a legal relationship to both their parents," said Lisa Bennett, who runs HRC FamilyNet. "These new census numbers demonstrate how critical it is for the law to catch up with the changing American family, by showing just how many same-sex couples are raising children today."

The report further showed that the average age of male partners ranged between 44.5 and 42.4, and that the average age of female partners ranged between 43.4 and 42.2. Comparatively, opposite-sex married couples have average ages in their late 40s, while unmarried opposite-sex households have an average age in the low to mid 30s.

"These numbers are interesting because they highlight the different rights that are bestowed on opposite-sex couples in this country, who are allowed to marry, and same-sex couples, who do not have marriage rights," said Smith. "The trend in this country right now shows people getting married later in life, which is why the average age of heterosexual married couples is older than the average age of heterosexual couples who are sharing a home but not yet married. Without the ability to marry or legally recognize their relationships, it is difficult to tell the statistical difference between same-sex couples who are living together, and same-sex couples who have made a lifelong commitment to one another."

Finally, the new report also gives insight into the number of interracial same-sex couples in the United States, with 11.5 percent of male same-sex households having multi-racial partners, and 10 percent of female same-sex households having multi-racial partners. Comparatively, 5.7 percent of married couples are multi-racial and 12.2 percent of opposite-sex partners are multi-racial.

"This new report on gay families shows us once again that gay and lesbian families are an undeniable part of the American landscape, and the time is long overdue for providing meaningful recognition of our families and relationships," said Smith.

## First transgendered student accepted into Hebrew Union College

Judaism's first transgendered rabbinical student was accepted into the Hebrew Union College –

Jewish Institute of Religion, the Reform movement's rabbinical seminary in Cincinnati announced this week. Reuben Zellman, a 24-year-old FTM (female to male transgendered person), plans to enter the seminary over the summer and spend his first year of studies in Jerusalem.

The Reform movement began ordaining gay rabbis in 1990, but Zellman's acceptance into the seminary is thought to be a first for a transgendered Jew.

"I realize it has political ramifications and I think those are positive, but I'm becoming a rabbinical student because that's what I want to do with my life," Zellman told the Jewish Telegraphic Agency.

#### June 19, 1979:

A judge in Catskill New York awarded permanent custody of a 13-year-old boy to his father, a gay minister. His reasoning was that the father does not abuse the child in any way, contrary to what he sees out of many "so-called straight people."

#### Japan elects first transgender official

The first transgender woman to seek election in Japan has won a municipal seat in Tokyo. That Aya Kamikawa even was allowed to run as a woman was seen as a major victory for the country's transgender community.

When she submitted her candidacy forms with a blank space for sex, election officials referred it to the federal government. Under Japanese law birth documents cannot be altered and Kamikawa had been listed as male. The transgendered in Japan are referred to as people "suffering gender identity disorder."

The government finally relented and allowed her to run as a female.

Kamikawa ran as an independent without any party support as one of the 72 candidates battling for 52 seats in the assembly.

Kamikawa placed sixth among all candidates in the election, assuring her a seat.

"I will proudly attend the assembly as a woman," Kamikawa said at her campaign office after the election results were announced.

#### July 21, 1414:

Fransesco della Rovere, who later became Pope Sixtus IV, was born. Shortly after being elected Pope, he appointed his lover as a cardinal.

#### July 16, 1982:

The US INS policy of barring homosexuals from entering the country was ruled unconstitutional by a federal judge.

Texas-Style Logic in Support of Same-Sex Sodomy Laws Before the Supreme Court (Most people know John Lawrence and Tyron Garner's story. In 1998, they were having consensual sex in John's home when police, responding to a false report of a gunman in the house, burst in and arrested them for violating Texas's "Homosexual Conduct" law. They were dragged out of the house in the middle of the night and kept in jail until the next day. Eventually, they were convicted and paid fines, and they are now considered sex offenders in several states.)

#### Charles Rosenthal, District Attorney, Harris County, Texas

Rosenthal's presentation focused on three points: 1) there is no constitutional or fundamental right to extramarital sex; 2) the state has a 'rational basis' for outlawing same-sex sodomy as an expression of 'moral disapproval'; and 3) Lawrence, Garner and the gay rights advocates had never proven that the two men were gay.

"Texas has the right to set moral standards and can set bright-line moral standards for its people," through the state legislature, Rosenthal told the court.

He insisted the law was about conduct, not homosexuality, noting that the state banned heterosexuals from committing samesex sodomy too.

#### GAY HISTORY with LISA DIGUARDI

#### June 29, 1989:

The Washington Times reported that VIP officials in the Reagan and Bush administrations were implicated in a federal investigation into a gay prostitution ring.

After being identified as one of those under investigation, Elizabeth Dole's adviser Paul Balach was forced to resign.

Republican National Committee chairman

Lee Atwater stated that it was wrong for people to
be forced out of their jobs because of something
that is strictly a personal matter.

#### GAY HISTORY with LISA DIGUARDI

#### June 17, 1981:

Sen. Roger Jepson (R-IA) introduced the Family Protection Act in Congress.

It specified that anyone who was homosexual or openly supportive of homosexuals could not receive student aid, social security, or veterans' benefits; and regulated what public school textbooks could say about human sexuality.

It never passed, and Jensen lost his bid for re-election when it was revealed he had a membership at a brothel.

#### Santorum sparks gay rights furor

Pennsylvania Sen. Rick Santorum, who ranks third in the Senate GOP hierarchy, came under fire from Democrats and gay rights advocates Tuesday after he said that a soon-to-be issued Supreme Court ruling may legalize sodomy and pave the way for legalization of polygamy, incest and other forms of sexual behavior that have traditionally been banned by the states.

"If the Supreme Court says that you have the right to consensual (gay) sex within your home, then you have the right to bigamy, you have the right to polygamy, you have the right to incest, you have the right to adultery. You have the right to anything," Santorum said in an interview with Associated Press, which was published Monday.

(Editor: Can you follow the logic that consenting sex between two adults of the same sex would pave the way for legalization of polygamy and incest, etc.?!)

#### ASSEMBLY PASSES HISTORIC GENDER NONDISCRIMINATION BILL (AB 196)

The State Assembly on April 21 approved AB 196 by Assemblymember Mark Leno (D-San Francisco), on a vote of 42-34. The bill would prohibit housing and employment discrimination based on gender non-conformity.

## APPROPRIATIONS COMMITTEE OVERWHELMINGLY APPROVES FOSTER CARE NONDISCRIMINATION BILL (AB 458)

On Wednesday the Assembly Appropriations Committee approved a bill that would protect foster children in the state from discrimination based on a range of factors including sexual orientation, gender identity, or HIV/AIDS status. The bill, AB 458 by Assemblymember Judy Chu (D-Monterey Park) was overwhelmingly approved 17-8.

#### LGBT VETERANS MEMORIAL BILL (AB 1520) FAILS TO PASS ASSEMBLY COMMITTEE

A bill by Assemblymember Christine Kehoe (D-San Diego) to create the first official California LGBT Veterans' Memorial failed to pass the Assembly Veterans Affairs Committee in a hearing Tuesday, April 29.

"It is a very sad day when legislators cannot even support a memorial to honor LGBT veterans who gave their lives for their country," commented Geoffrey Kors, CAPE Executive Director. "This proposal was simply to allow private funding for a memorial that would have recognized a group of veterans who died while being forced to serve their country in silence."

#### And here some thoughts from Assemblymember Dave Cox:

Thank you for your thoughtful correspondence regarding Assembly Bill 196. I appreciate hearing from you again.

My record in the legislature has been clear on this issue. Bills that attempt to undermine the sanctity of traditional marriage as well as the will of the voters as expressed by the passage of Proposition 22 have not received my support.

Several bills have been introduced this session that are being promoted as steps to further the rights of homosexuals, lesbians, bisexuals and transgenders. Upon reviewing these bills I have found that they fall into 2 distinct categories: 1. Cause Damage to California Employers: AB 17 (Kehoe) could create greater demands on businesses in California by excluding them from the open bidding process. AB 18 (Leno) could spawn a much more litigious environment than already exists in our state by creating a special class of individual based on sexual orientation. AB 196 (Leno) would enforce a definition of "gender identity dress" which is so vague that any person who is not hired or is terminated could cite the provisions of AB 196 as grounds for litigation and demand damages. Companies, in effect, would be handcuffed by state law and out of fear would be required to hire "transgenders" to avoid being named in a damaging lawsuit even if doing so costs them business; or

2. Subvert the Traditional Understanding of Family: AB 205 (Goldberg) would effectively repeal Proposition 22 which 61% of Californias voters approved.

AB 458 (Chu) would adopt specialized training requirements for foster parents and foster care staff and grant special rights to foster children on the basis of actual or perceived race, ethnic group identification, ancestry, national origin, color, religion, sex, sexual orientation, gender identity, or mental or physical disability. This legislation is unnecessary existing statute already prohibits discrimination based on the above categories in the delivery of public services. Furthermore, AB 458 could discourage people of faith from serving as foster care parents altogether. This would be a tragedy for children who already have few options when it comes to foster families.

AB 196 passed the Assembly on April 21, 2003 by a vote of 41 to 32. None of the Republican Assembly Members voted for the measure.

Again, thank you for informing me of your position. It is my hope that there will be other issues upon which we can agree. If I can be of assistance to you in the future, please do not hesitate to contact me.

### OFF THE BOOK-RACK



"The Preacher's Son"

Marc Adams

When I heard Marc Adams speak at one of our PFLAG meetings, I was very impressed by his story. He had the courage to step out of a very confined rigid fundamentalist environment that regards Rev. Jerry Falwell as a liberal. Today, Marc is the executive director of HeartStrong Inc., a non-profit organization that offers help and hope to GLBT students of religiously-based educational institutions. http://www.heartstrong.org

This book is the story of a courageous man who already knew as a kid that he was "different". He grew up with parents who adhered to the fundamentalist Baptist vein of Christianity where physical punishment was justified. Their belief was that their Bible contained the actual words of God. Surrounded by a homophobic atmosphere Marc understood at a very young age that it was wrong for him to have any feelings for other boys. In elementary school, Marc made friends with Stephen and one day his mother asked: "Have you ever kissed Stephen?" – as a precaution the parents enrolled Marc at a private, church-sponsored school the very next year. At age 14, he heard a preacher ranting about AIDS: "Homosexuals are nothing more than child molesters and sexual deviants. This disease can be contracted through handshakes, public toilet seats or even just breathing the same air as a homosexual." 'I didn't want to grow up to be a bad person. I certainly didn't want to die or cause other people to die. When I got home to my room, I fell on my bed and cried myself to sleep. For the first time in my life, I felt alienated from God.'

Marc enrolled at Jerry Falwell's Liberty Baptist College hoping that there couldn't be any homosexuals in attendance. He was wrong. Struggling with his own feelings, college time became a rollercoaster. He and Todd became close friends. Eventually Todd left and then came back to tell Marc that he had changed and finally found victory. 'If Todd wasn't lying about his change, then I must be doing something wrong.'

He witnessed how two young men were turned in for having a sexual relationship and immediately were kicked out of the university. Kent: "My father's going to kill me." - but then it was Kent who took his own life.

Finally Marc's awakening. 'Without the fundamentalist ideology, I could live as a gay man and feel content and proud instead of inferior and troubled.' Marc and Todd were back together as a couple (after all Todd couldn't make his feelings go away), rejected by Marc's family who told Marc that Todd and he were not welcome to stay together in their home.

Marc's mom: "Well, there's not much more to say. You know we have to follow what's in God's Word." And a letter from his dad made Marc understand that he's no longer a preacher's son...
