## Legislative Corner (By Eve Lubalin, Advocacy Chair)

#### California Makes Marriage History Again!

The Assembly Judiciary Committee made history by being the first state legislative body to approve equal marriage rights for gays and lesbians. By an 8-3 vote, the Committee approved Assemblymember Mark Leno's Marriage License Non-Discrimination Act, AB 1967, which amends the family code to define marriage as between "two persons." Gender-specific language was first added in 1977.

Critical in the debate, the committee's report on AB 1967 indicated the bill *does not violate Proposition 22*, the ballot measure approved in 2000. Anti-gay groups argue Prop 22 limits marriage to a man and a woman. But, concurring with the Judiciary Committee's report, Leno, the National Center for Lesbian Rights and Lambda Legal agreed that Prop 22 deals with a much narrower issue -- whether California must recognize out of state same-sex marriages – and does not address the state's legal definition of marriage.

Next stop for AB 1967 is the Assembly Appropriations Committee, responsible for assessing the fiscal impact of the bill. Partly because of the state budget crisis, and partly because of election year politics, the Committee may take no further action and kill the bill. It faces a May 21<sup>st</sup> legislative deadline. If the Committee does approve AB1967, Assembly Speaker Nunez is unlikely to schedule a vote.

#### **Equal Marriage Rights Asserted in California Courts**

- The California Supreme Court is expected to hold hearings on two marriage-related issues in late May or early June: Did Mayor Newsom exceed his authority by issuing marriage licenses? Should the more than 4000 marriages performed in San Francisco be invalidated?
- A San Francisco Superior Court will conduct a trial later this year on the constitutional issues: Does California's family code violate the state constitution by limiting marriage to a man and a woman?

#### Supreme Court to hear SF gay marriage flap May 25

SAN FRANCISCO (AP) The California Supreme Court announced Wednesday it will hold oral arguments May 25 on the question of whether San Francisco Mayor Gavin Newsom had the authority to issue same-sex marriage licenses.

The seven-member court said it would devote two hours to the arguments. Under court rules, the **justices must rule within 90 days.** The cases, brought by Attorney General Bill Lockyer and the Alliance Defense Fund, a conservative group opposing gay marriage focus almost exclusively on whether Newsom could issue same-sex marriage licenses by unilaterally declaring that same-sex marriage, should be lawful. California family laws, however, define marriage as a union between a man and woman. The high court stopped gay marriages here at City Hall last month after 4,000 gays were wedded, pending the outcome of the challenges.

Lockyer and ADF said upholding Newsom's actions would give other government officials approval to subvert other laws. The justices this month asked the parties whether they should nullify the roughly 4,000 marriages if they side against Newsom. But the justices have not made clear whether they would invalidate the marriages even if they say Newsom erred.

Lockyer has taken no position on gay marriage, but told the justices the marriages should be invalidated because Newsom overstepped his authority. The Arizona-based ADF agreed with Lockyer but also disapproves of gay marriage.

For his part, Newsom said his interpretation of the California Constitution demanded that he issue the licenses. The justices, however, announced last month that they would not address that topic. That issue is not expected to be before the justices for at least a year or more, as that battle is brewing in the lower courts.

The San Francisco-based court will hear the two cases at 9 a.m. here in its courtroom. The cases are Lockyer v. San Francisco, S122923, and Lewis v. Alfaro, S122865.

## 12 Reasons Same-Sex Marriage will Ruin Society

#### LGBT Federal Workers Lose Job Protections

(Washington, D.C.) Gay and lesbians in the entire federal workforce have had their job protections officially removed by the office of Special Counsel. The new Special Counsel, Scott Bloch, says his interpretation of a 1978 law intended to protect employees and job applicants from adverse personnel actions is that gay and lesbian workers are not covered.

Bloch said gays, lesbians and bisexuals cannot be covered as a protected class because they are not protected under the nation's civil rights laws.

Bloch was appointed by President Bush to a five year term beginning in January.

#### China recognizes transsexual's marriage

In a first for China, a transsexual received a marriage certificate.

Zhang Lin, from Peng Township, Shuangliu County in Southwest China's Sichuan Province, obtained the certificate after being officially recognized by the state with a new ID card.

This was the first marriage certificate issued to a transsexual in China, the Yangcheng Evening News reported on Tuesday.

Zhang Lin, 37, and her husband, Yang Qicheng, planned to hold a marriage ceremony on May 1 with 500 guests.

Zhang had married a woman before her sex reassignment surgery and has a 12-year-old daughter from that marriage.

#### Smear Campaign Targets TX GOP xdresser

(Fort Worth, Texas) Sam Walls won't say what he was doing in the dress, but pictures of the 64 year old Republican candidate for the Texas House in full makeup, a wig, heels, and a dress, have been anonymously distributed to voters.

A leading businessman and former party chairman, Walls was the favorite to win, until the photographs surfaced.

#### Son of anti-gay politician Knight marries same-sex partner

David Knight, son of the California state senator who put a ban on samesex marriage in the books, stood against his father's law and stood up for marriage equality by marrying his partner of 10 years, Joe Lazzaro, in San Francisco.

Knight's father is state Sen. William "Pete" Knight, R-Palmdale. In 2000, Knight authored Proposition 22, the law which declares, "Only marriage between a man and a woman is valid or recognized in California."

#### Tennessee County's Vote to Ban Gays Protested

DAYTON, Tenn. - More than 400 people turned out Saturday May 8 for a Rhea County Gay Day celebration prompted by the county commission's vote to ban homosexuals and have them arrested for "crimes against nature."

A Friday demonstration against homosexuality in Dayton included preaching on the lawn of the courthouse where a jury in 1925 convicted John Scopes for teaching evolution.

On Saturday, same-sex couples holding hands joined heterosexual couples at the park in the town of 6,200 people. Russ and Jennifer Bridges of Ringgold, Ga., sat listening to activists speak. "I'm not gay," Russ Bridges said. "It's all about humans getting together for a common cause."

#### Politician Announces He's Transgendered

(Rapid City, South Dakota) South Dakota's only out politician announced that he is preparing to undergo sex reassignment to become a woman. Tom Murphy said that he had "pretended long enough." Murphy said he has identified with females more than with males since he was young.

He began visiting Internet chat rooms after he retired from a 22-year military career. "I found out I'm not alone," he said. "It's just amazing, the common bond we have."

It is believed the Murphy will be first sitting transgendered politician in the United States.

#### A child's worst nightmare - losing a parent due to our inhumane immigration laws Part 2

When I heard 15-year old Marina Gatto speak at a rally in Sacramento I was deeply moved. If we, as a nation, keep our inhumane immigration policy that does not recognize same-sex couples, this child will lose one of her moms soon. And so will many others.

# MARINA GATTO 15 yr. old LGBT activist

I began being very active as an activist when I was about 8 or 9 years old. Mark Leno was my idol. He was a San Francisco Supervisor, and someone from my own community that I saw making change and fighting for our community. I wanted to be just like him!! At 14 years old I began working with Mark Leno who was now a California State Assemblymember, helping get bills like A.B. 205 passed.

When I speak about my family I get an amazing and positive response from people. I truly believe that most people simply just do not understand differences, and the issue of equality and how it applies to LGBT people and families. When they have a face to an LGBT family and a child of that family, and when they hear how discrimination and lack of rights affects us, they are touched and surprised.

The place that I found the least support was in school through my years up to high school. School is suppose to be a place where all children should feel safe, and have every opportunity to learn and know they are protected. In fact, this is usually not the case. Sadly, it was most often the teachers that I faced the most hate and discrimination from.

There are many things that I have experienced as a civil rights activist that have been traumatizing and terrible. From people constantly committing hate crimes to our house, vandalizing our car and our home, threatening us, throwing rocks and fruit at us over fences when we are in our backyard, driving by and yelling hateful remarks at us, and even trying to set the pride flag on our house on fire. I keep myself motivated to keep fighting passionately for equality and for civil rights because it is impossible to escape the injustice that we face and live with every single day of our lives. Sometimes it is extremely painful, frustrating, and overwhelming. But I see how hard it is for one of my moms to go to school full time simply to be

allowed to stay in this country, pay over 13 times the rate of a U.S. student, work so hard just to pay for her school, be a leader and an activist in the LGBT community, AND be a wonderful and loving mother and partner to my other mom. My family struggles so hard, never gives up, and we still manage to somehow keep up our passion to work for change. When I look at my moms sometimes and see how tired they are, how hard they work, and how they struggle to give me every opportunity and everything they can, how can I feel sorry for myself? I realize how lucky, how blessed I am. It makes me want to make a difference for them, make the world a better place for them, easier for them, and for so many countless other families and parents too! One of the main arguments I hear against marriage for gays and lesbians, or against LGBT families is that children need a mother and a father. All one has to do however, is to look around them at society today. There are countless kids who have a mother and a father who are unhappy, unsuccessful, and simply not doing well. There are also just as many kids who are being raised by just a mother, a father, a family member, or same sex parents who are well adjusted, thriving, happy, and are proud of the families and communities that they come from. It's less important for a child to have an example of a relationship with a man and a woman, than it is for a child to have an example of a relationship with two people who love, respect, and are committed to each other. I hear all the time the argument that children of LGBT parents will be deprived of good families, they will not be happy, well adjusted, or sure of who or what they are. I believe I am living proof that is simply not true. I am an honor student, sophomore class president of my school, a varsity athlete, a leader of the LGBT community, and an accomplished, and nationally recognized civil rights activist at the age of 15 years old! I love my parents deeply and am proud of the community that I come from.

#### Kansas Lawmakers Reject Gay Marriage Ban

TOPEKA, Kan. - A proposed constitutional amendment declaring that Kansas recognizes marriage as only between one man and one woman failed to win enough House support to submit it to voters.

The vote was 79-45 - five favorable votes fewer than the twothirds majority needed to approve a proposed change in the Kansas Constitution. The Senate adopted the proposal on a 27-13 vote.

The proposal would have also denied legal benefits associated with marriage to other domestic arrangements, such as civil unions.

## California Board Rejects Discrimination Code

WESTMINSTER, Calif. -- A small California school district has refused to recognize a state law banning discrimination against transsexuals, a decision that could cost it millions of dollars in state and federal funding.

Three of five trustees on the board of the Westminster School District in Orange County said they oppose the rules because they are Christians.

"I might take a lot of heat for it today, but the rewards are going to be great in heaven," said Judy Ahrens, one of the three.

## Popular Clownfish Can Change Sex

Scientists could have written an R-rated, genderbending plot twist to Disney's "Finding Nemo": Clownfish have a natural ability to change their sex.

Clownfish, the aquarium pet of choice since the release of the animated movie, live in such a rigid social structure in the wild that if one of the dominant breeding adults is removed, the size, status and even sex of the other clownfish change rapidly to return the group to the status quo.

"If the female of the group dies, the male changes sex and becomes the breeding female," said Cornell University evolutionary biologist Peter Buston, "while the largest non-breeder becomes the breeding male."

Some other species of fish are known to do the same thing.

#### **Germany Expands Gay Partner Rights**

(Berlin) A German court has ruled that the civil service and all government agencies must pay benefits to the partners of same-sex couples equal to those they pay to the married spouses of heterosexuals.

In their ruling, the judges said that there is no difference between a registered life partnership and marriage when it came to remuneration in the public service.

## Thoughts On Same-Sex Marriage & Procreation (By Janis Walworth)

Those who believe that same-sex marriage will endanger the survival of the human species apparently haven't noticed that humankind is not at risk of becoming extinct through lack of reproduction. On the contrary, the greatest threats to 21st century civilization stem from overpopulation.

But we don't need a law against taking religious vows to prevent that from happening.
