PRESIDEILL'S MESSAGE

Our son Paul happens to be gay. I suspected for several years. It was his lack of interest in girls. When a beautiful girl walked by and I looked, Paul would not. I would ask his mother and she would say "No, he is not gay. He is just not as interested as you are in sex." One evening, Paul took me aside and told me that he was gay. I cried a little and then hugged him. He was only the second gay person I had ever met in my life - or so I thought at the time.

His mother and I have loved Paul every day of his life. His coming out wasn't a big surprise to me and mattered only a little. He was still the beautiful, wonderful boy that we loved. After Paul came out at home, things were much better. Later that year, Paul and I traveled to Atlanta to the GLSEN National Conference. For Paul, it was "the best time of my life." For me, it was expanding my circle of gay acquaintances from three to hundreds! I stood at one evening's reception, in a room filled with gay men, lesbians, bisexuals, and transgender individuals, and felt completely fine. They were just so darn ordinary. Most, the vast majority, were plain boring just like me. Just regular people who want to live and let live, who want to work and enjoy the fruits of their labor in our great country without fear of job loss and abuse. I realized then that I had met many gay and lesbian people throughout my life, but just never knew it.

Along the way, our family came to PFLAG (Parents, Families, and Friends of Lesbians and Gays). At the beginning we came for education, but we soon graduated to a fierce advocacy – the advocacy dedicated to confront all those who seek to deny equal rights to GLBT people.

Last year, I was fortunate enough to see our son Paul graduate college. I know the challenges he faced in his University - tough exams and tough professors were the least of it. But he survived. He is now trying to break into the world of work with all the challenges that that brings. He is a good citizen and wants to live and enjoy the fruits of his labors in our wonderful country. He also wants to find a life partner, just like any other young person. When he finds his life partner, he should be able to enjoy the same benefits as any other person, gay or straight. This includes marriage with all the rights thereto. Those intent on denying my son of this right do so out of convictions that I do not share. My position is that marriage is a basic right that all persons share, regardless of their sexual orientation or gender identity. Despite a Federal push for constitutional amendment to ban same-sex marriage, more and more of the fair minded citizens of our country now accept basic rights for gay and lesbian citizens, with a majority supporting civil union. How enthralling it is to see this monumental shift in public attitude.

Same-sex marriage is now legal in Massachusetts – something unimaginable only months ago. Despite the agitation of the homophobic community, I strongly believe that this trend will sweep the country over time, but not without all of our efforts. Now is the time for us, as parents, friends and family of the GLBT community, to lock our arms and work together to ensure this future for our children.

I am honored to serve as your Co-President and look forward to locking arms with each of you.

LEGISLATIVE CORNER (By Eve Lubalin, Advocacy Chair)

California Legislators Put Equal Marriage Rights On Hold

But Assembly Speaker Indicates Support in 2005 and State Officials Endorse Bill

After the historic approval by the California Assembly Judiciary Committee of AB 1967, the Marriage License Non-Discrimination Act -- which would make state marriage laws gender neutral -- the bill was held by the Assembly Appropriations Committee past its deadline for approval, denying supporters a vote on the measure in the Assembly this year. While the bill fell victim to budget and election year politics, members opposed to legislative action argued that consideration should be deferred until state courts rule on equal marriage rights cases pending in state courts.

- California's Supreme Court will soon rule on whether Mayor Newsom exceeded his authority in having the County of San Francisco conduct same-sex marriages and, if so, whether the marriages conducted shall be nullified.
- Later this year, the California Superior Court in San Francisco will rule on state constitutional issues: Does the California Constitution provide for equal marriage rights for all Californians?

In announcing the decision to pass over the bill this year, Assembly Speaker Nunez (D- L.A.) committed to co-authoring it next year, signaling his intention to move forward on marriage legislation. On the eve of Committee action, four major statewide elected officials – Secretary of State Shelley, State Treasurer Angelides, State Controller Westly and Insurance Commissioner Garamendi – also endorsed AB 1967, further boosting chances for action next year.

One key player is missing in action: Governor Schwarzenegger! Despite telling *Jay Leno* that he was "fine" with same-sex marriage if the people, state legislature or state courts were for it, the Governor has neglected to tell *Assemblymember Mark Leno* that he supports the bill!

ACTION ALERT!

Opponents of equal marriage rights are bombarding the Governor's office with messages opposing the bill. Contact Governor Schwarzenegger and tell him you support AB 1967 – and equal marriage rights for all California couples. A letter to the Governor does not have to be long or complicated! Just tell him how you feel and that it is a top priority for you, your family, and your friends. AB 2900 / Employment Non-Discrimination Bill Passes Assembly!

The Assembly voted 48-32 in favor of AB 2900 (John Laird, D-Santa Cruz). AB 2900, the Omnibus Labor and Employment Non-Discrimination Act of 2004, will standardize over 30 labor and employment non-discrimination provisions to make them consistent with the Fair Employment and Housing Act (FEHA). The bill now moves to the State Senate.

AB 2208 / EQCA's California Insurance Equality Act Passes Assembly!

On Thursday, May 20, the California State Assembly passed AB 2208, EQCA's California Insurance Equality Act, by Assemblymember Christine Kehoe (San Diego), on a 45 to 31 vote. This bill, sponsored by Equality California and Insurance Commissioner John Garamendi, will amend the Insurance and the Health & Safety Codes to prohibit insurance providers from issuing policies or plans - including health, life, auto, renters and homeowners insurance, among others - that discriminate against registered domestic partners. The bill now moves on to the Senate.

SB 1234 / Comprehensive Hate Crime Bill Passes California State Senate!

The Senate voted 22-10 in favor of SB 1234 by Senator Sheila Kuehl (D-Santa Monica) and sponsored by Equality California. SB 1234, the Omnibus Hate Crimes Act of 2004, will create a uniform definition of a hate crime, clarify the law, and provide tools designed to reduce such crimes. The bill now moves to the state Assembly for further consideration.

Marriage as a Ceremony or Contract

The act, formality, or ceremony by which the marriage union is created, has differed widely at different times and among different peoples. One of the earliest and most frequent customs associated with the entrance into marriage was the capture of the woman by her intended husband.

The judiciary is supposed to protect the minority from the tyranny of the majority. It is precisely the job of the court to protect minorities and unpopular groups of people from being persecuted.

Homosexuals are not a racial minority, but they still deserve equal protection under the law. You don't need to be a race to be a minority, and you don't need to be a minority to deserve equal rights and equal protection. Equal protection is for everyone, whether it is a choice or not, and separate is never equal.

In this state, Baptists are a minority. Yet, nobody has called for a referendum on the rights of Baptists to marry other Baptists. Don't Baptists deserve equal rights and equal protection under the law even though they are not a racial minority and they have chosen their particular lifestyle? Do "The People" have the right to put the value of that lifestyle to a popular vote?

Permanent Partners Immigration Act

Assembly Joint Resolution 60, a measure by Assemblymember Sally Lieber in support of the federal Permanent Partners Immigration Act (PPIA) received committee approval, moving it one step closer to final passage in the California Assembly.

This is the first step in a process that hopefully will make California the first state in the nation to go on record in support of the federal bill.

Did you know that current immigration law prohibits U.S. citizens to sponsor their same-sex foreign partner for residency here in the United States? These couples/families have three options: Break up; emigrate to another country that has humane policies in place and allows same-sex binational couples/families to stay together; or, live in constant fear of deportation once the foreign partner's visa has expired.

The Japanese American Citizens League voted 50-38 at its meeting in San Francisco in favor of supporting samesex marriage.

Connecticut adds transgender hate crime law

Connecticut joined seven other states that protect transgender people in hate crime laws when Republican Gov. John Rowland signed the legislation last Friday.

The state Senate unanimously passed the inclusive hate crimes bill in April, after the House had passed the bill 139-4. Many of the legislators who signed onto the bill, including the co-chair of the joint Senate and House Judiciary Committee, Sen. Andrew J. McDonald, said they supported it because of moving testimony from members of the transgender community.

The new provision to Connecticut's hate crimes law goes into effect Oct. 1. The other states to include transgender people in their hate crimes statues include California, Hawaii, Minnesota, Missouri, New Mexico, Pennsylvania and Vermont.

Rita Hauser, Republican US representative to the United Nations, spoke to the American Bar Association in favor of legalizing same-sex marriage, saying laws against it were based on the mistaken notion that the purpose of marriage must be procreation.

"Conscientious Objector Policy Act"

On April 21, the Michigan House of Representatives passed legislation that would allow doctors and other health care providers to refuse services to anyone on moral, ethical or religious grounds. The providers could not be disciplined or sued for such refusals.

Sex change for soccer star

Lagos - A top Nigerian female football star, Iyabo Abade, is set to undergo a sex change operation in the United States.

According to The Saturday Punch newspaper the onetime free-scoring striker in the Nigerian women's league is to undergo the operation at the Midway Hospital in Beverly Hills, California, after American doctors discovered she had more male hormones than female.

The newspaper reported that lack of funds has forced the date for the operation, initially fixed for May 18, to be moved.

Switzerland adopts civil unions

On June 10, the Swiss parliament cleared the final hurdle for a new law allowing same-sex couples to register their partnerships: a bill that provides for inheritance rights and the rights of foreign partners.

Doris Leuthard, the interim president of the Christian Democratic Party, which has a constituency that is primarily Catholic and known for its stance on traditional family values, described the bill as "a major improvement".

"Registration gives rights that are comparable to the rights of marriage, even if it is does not allow for marriage like in some European countries," said Leuthard.

DID YOU KNOW?

It was not until the end of the 70s that the Catholic marriage laws were changed, thereby allowing men who could copulate, but not procreate, to marry.
