# PRESIDENT'S MESSAGE

#### BLACK AND WHITE

As the November election approaches and our country again selects its President for the next four years, I can't recall a time when the issues that each party bases its platform on were so distinct and so different.

I encourage our membership to read the recently drafted platforms so that you can see how, if at all, the GLBT community is looked upon.

The Republican platform reads\* in a section titled Protecting Our Families, "We further believe that legal recognition and the accompanying benefits afforded couples should be preserved for that unique and special union of one man and one woman which has historically been called marriage." The word gay or lesbian does not appear anywhere in this platform. The only mention of the word homosexuality appears in a section describing it as "incompatible with military service." No legal recognition and no accompanying benefits for couples other than one man and one woman. Enough said.

The Democratic platform reads\* in a section titled A Strong American Community, "We support full inclusion of gay and lesbian families in the life of our nation and seek equal responsibilities, benefits, and protections for these families."

I believe strong conclusions can be drawn from these two distinct statements. I'm still amazed by the number of people in the country who just don't vote. Registration is easy and you can register as late as 30 days before the election in most states, and as late as 15 days before the election in California. Go to www.eac.gov and click on Register to Vote on the right hand side. I STRONGLY encourage you to ask your friends and families in other states to vote in this election as well. We saw from the election 4 years ago how a single vote can matter.

#### SAN FRANCISCO MARRIAGES VOIDED BUT FIGHT CONTINUES

Constitutional Challenge Moving Forward; Marriage Legislation to be Re-Introduced

On their six month anniversaries, nearly 4000 couples married in San Francisco were involuntarily "divorced" by the California Supreme Court, which ruled that Mayor Gavin Newsom overstepped his authority by permitting same sex marriages to be conducted. While the Court declared the SF same-sex marriage licenses invalid, its decision did not address whether same-sex couples had the right to marry under the California Constitution. That critical issue will be decided in a separate lawsuit pending in SF Superior Court, filed by the City of San Francisco, several LGBT legal groups and same-sex couples who charge that the state's marriage law is discriminatory and should be overturned. A final resolution of the constitutionality of California's marriage law will not be reached for a year or more. Meanwhile, families will be denied critical legal and economic protections, along with the dignity and respect they deserve.

The pending San Francisco case is similar to a Massachusetts lawsuit that led to ordering the issuance of marriage licenses to samesex couples statewide. Oregon and Washington courts have issued similar decisions, which will be reviewed soon by their highest state courts.

While California courts review our marriage laws, a simultaneous effort to change the law is moving forward in Sacramento. The Marriage License Non-Discrimination Act, AB1967, will be re-introduced by SF Assemblyman Mark Leno in December. This time around, the bill will have the critical support of Assembly Speaker Nunez and four statewide officials – Secretary of State Shelley, State Treasurer Angelides, State Controller Westly and Insurance Commissioner Garamendi. Governor Schwarzenegger is the missing link! He has not yet taken a formal position on the bill, although he has said he "has no problems" with same-sex marriage if the courts or legislature approve it.

#### AJR 60 / Assembly Joint Resolution 60 in support of the U.S. Permanent Partners Immigration Act Passes State Senate!

AJR 60 by Assemblymember Sally Lieber (D-Mountain View), also sponsored by EQCA, urges Congress to pass the Federal Permanent Partners Immigration Act in order to allow American citizens and permanent residents to sponsor their same-sex partner to live in the U.S., just as spouses can under the principle of family unification. The resolution passed the Senate by 21-12.

#### AB 2208 / EQCA's California Insurance Equality Act Passes State Senate!

The California State Senate passed 23-12 Assembly Bill 2208 that requires that insurance providers treat registered domestic partners and married spouses equally. This bill was authored by Assemblywoman Christine Kehoe (D-San Diego) and officially sponsored by Equality California and Insurance Commissioner John Garamendi, plus supported by a coalition of labor, business, civil rights, and LGBT organizations.

#### SB 1234 / Comprehensive Hate Crime Bill Passes California Assembly With Bipartisan Support!

The California State Assembly voted 51-23 in favor of SB 1234 by Senator Sheila Kuehl (D-Santa Monica) and sponsored by Equality California. This vote marks the first time that a bill sponsored by Equality California has received bipartisan support with four republicans voting in favor of the measure. The four Republicans voting in favor of the bill are: Assemblymember Bonnie Garcia (R-Cathedral City), Assemblymember Shirley Horton (R-Chula Vista), Assemblymember Abel Maldonado (R-Santa Maria), and Assemblymember Keith Richman (R-Northridge).

(KRT) - I'm straight. The female of the species sets off my bells and whistles. Being straight, I don't understand the gay and lesbian experience. I can't relate to feeling a physical attraction to someone of my own sex.

But being white, I don't understand the experiences of persons of color, either. I haven't a clue what it's like to be a minority in a nation dominated by another race.

And being male, I don't understand the female experience. Man, do I not understand the female experience.

But even with my lack of understanding, I do know a few things about these folks who are different from me in one way or another. I know that, like me, they didn't choose the pigmentation of their skin. I know that, like me, they didn't choose their sex. (OK, some folks are choosing their sex these days, but not right out of the womb.)

I know that, like me, they didn't choose their sexual orientation. Gays and lesbians can no more change that part of their being than I can change the gene that relocated most of the hair from my head to parts of my body where it's unwelcome.

So, here I am, a straight, white, male American. And all around me are other Americans, many of whom are not male, some of whom are not white and some of whom are not straight. Does that make them less American than me? Does that make them less deserving of the rights, privileges and legal protections that come with the name? Of course not.

There was a time in this country when people of color were denied those rights, privileges and protections. But we, as a society, recognized the wrongness of that situation. We changed our laws and most of our attitudes.

There was also a time in this country when women were denied some of those rights, privileges and protections. But we, as a society, recognized the wrongness of that situation, too. We changed our laws and most of our attitudes. But we, as a society, continue to deny gays and lesbians some of the rights, privileges and protections that come with being Americans.

In Kentucky and most other parts of the country, gay and lesbian couples cannot marry. And even in those few islands of enlightened tolerance where such marriages are being performed, gay and lesbian couples cannot avail themselves of the benefits of marriage under federal law.

According to the General Accounting Office, there are more than 1,100 federal statutory provisions that make marriage a factor in receiving benefits, rights and privileges. All are denied to gay and lesbian couples. Because the federal government and most states don't recognize the marriages of gays and lesbians, they don't enjoy the inheritance rights, insurance benefits, tax advantages and hundreds of other privileges that are virtually automatic for married couples.

We justify this discrimination against our fellow Americans by quoting chapter and verse from the Bible. Perhaps the verse we cite is Leviticus 20:13: "If a man lies with a male as he lies with a woman, both of them have committed an abomination. They shall be put to death. Their blood shall be upon them." If we base our laws solely on the words of the Bible, our course is clear. We must kill all gays and lesbians.

But we cannot stop there, because the verses surrounding Leviticus 20:13 tell us that we must also "put to death" many others as well - those who curse their mother or father, those who commit adultery, those who curse or blaspheme the Lord and those guilty of assorted other crimes. Some must be stoned. Some must be burned. We can be creative about how we slay the rest.

If we copied and pasted Leviticus directly into our statutes, our noncapital crimes would include shaving our heads or trimming our beards; marrying a divorced woman; eating pork, shellfish or rabbit; and working on Sunday, presumably even for the clergy.

But while our laws share certain principals with biblical teachings, our laws as a whole are secular. And rightly so, since this is a nation of many religions, not one, a nation that cherishes its religious freedom and diversity. In this land of secular laws, marriage is a legal institution, not a religious one. Churches may sanctify marriages. And they may choose not to sanctify same-sex marriages if they believe homosexuality is a sin. That is their right, and it should never be denied them.

But only government sanctions marriage. You can get married without a church, a minister or any reference to religion. You can't get married and enjoy the legal benefits of marriage without a government-issued license. When you accept the fact that marriage is a legal institution rather than a religious one, all the arguments against same-sex marriage melt away, because all of them ultimately are rooted in religious beliefs.

All that is left, then, is one simple question. It's the question put before Kentucky voters this fall in the form of an amendment that would embed in constitutional concrete the state's existing law prohibiting same-sex marriages.

Should we deprive gays and lesbians of the rights, privileges and protections enjoyed by other Americans?

In "Death in the Afternoon," Ernest Hemingway wrote, "I know only that what is moral is what you feel good after and what is immoral is what you feel bad after."

I know that if I cast a vote for this amendment, I would feel bad afterward. I would feel immoral.

I would feel immoral because the folks who will suffer the consequences of this amendment are our co-workers, friends, family members. I cannot and will not tell any of them they are less deserving than me simply because they were born gay or lesbian while I was born straight.

### Washington State & the right to marry

August 4, Seattle:

Gay couples can be married under Washington state law, because denying their right to do so is a violation of their constitutional rights, a judge ruled Wednesday.

"The denial to the plaintiffs of the right to marry constitutes a denial of substantive due process," King County Superior Court Judge William L. Downing said in his ruling.

#### September 8, Olympia:

Washington's ban on same-sex marriage was struck down Tuesday by a second judge, who ruled that marriage is a fundamental right that should be available to gay men and lesbians.

Thurston County Superior Court Judge Richard Hicks held that Washington's Constitution offers broad guarantees of equality. He said that those guarantees are violated by the state's 1998 Defense of Marriage Act, which defines marriage as the union of a man and a woman and bars same-sex civil marriage. The state "must take care to treat all its citizens in an equal way," he said.

# Portugal's constitution bans discrimination based on sexual orientation

Portugal is the first country in Europe and (after Ecuador, Fiji and South Africa) the fourth worldwide to explicitly ban sexual orientation discrimination by constitutional legislation.

On July 24, 2004, Constitutional Law no. 1/2004, amending (for the sixth time) the Portuguese Constitution, was published ("Diário da República" [official gazette], no. 173, of July 24, 2004). It goes into effect, on the mainland, on July 31, 2004, and on the Azores and Madeira Regions on August 10, 2004. Therefore, article 13 of the Portuguese Constitution now officially states that:

- 1. All citizens have the same social rank and are equal before the law.
- 2. No one shall be privileged or favoured, or discriminated against, or deprived of any right or exempted from any duty, by reason of his or her ancestry, sex, race, language, territory of origin, religion, political or ideological convictions, education, economic situation, social circumstances or sexual orientation.

### Republicans Endorse Ban on Gay Marriages

NEW YORK - August 25, Republicans endorsed an uncompromising position against gay unions in a manifesto that contrasts with Vice President Dick Cheney's supportive comments about gay rights and the moderate face the party will show at the national convention.

# **Los Angeles City Council Approves PPIA Resolution** August 4, 2004
